

CALL TO 2-D & 3-D ARTISTS

ELEMENTS

Works in stone, clay, metal, fiber, wood and glass.
Theme and style of art is completely open.

RULES & RESTRICTIONS: All work must be the artist's original work. No reproductions will be accepted. All works must have been completed within the last two years, and must not have been displayed previously in a competitive exhibition at the Broward Art Guild. The Juror ultimately selects the collection of works to exhibit, and has right of refusal if the above criteria have not been met. Venue has right of refusal of work that are deemed inappropriate for a professional gallery setting.

PAINTINGS AND FRAMED PIECES Must be wired for hanging. All wall-hanging works must be properly wired for hanging and 3-D works must be assembled in a professional manner for pedestal or floor display. 2-D pieces cannot exceed **36" wide by 36" high** maximum, or without prior special permission from the Guild before delivery. **Installation pieces.** For all installation pieces or works requiring special handling or assembly, artists are required to submit in writing (prior to intake) a description of the work and a photo depicting proper displaying. The Artist is requested to install the work for exhibition at the Guild's convenience. Unframed canvasses must be gallery wrapped (no staples showing) and either have image painted around all sides, or sides presented clean.

ENTRY FEES: First entry - \$12.00 members, \$25 non-members. \$8.00 per additional entry. This exhibition is open to all artists.

NEW MEMBERSHIPS WILL BE ACCEPTED AT INTAKE, ON OUR WEBSITE (www.BrowardArtGuild.org), OR AT THE GUILD OFFICE PRIOR TO INTAKE.

Fees are not refundable. Due to space considerations it may sometimes be necessary to limit pieces chosen by juror. As a juried exhibition, the juror is the final arbiter for work accepted into the exhibition.

B.A.G. NUMBER SYSTEM: All works will be identified by an entry number assigned to each piece at the time of registration. Use these numbers when inquiring about your entries. You can call the guild office at 954-305-1854 on the **Wednesday** following intake to check on acceptance into the exhibition between the hours of 11:00am and 4:00pm. Works not accepted into the exhibition must be picked up in a timely manner to avoid storage fees.
